3. Shipping Documents

The following documents and information must be provided before delivery:

- Delivery bill: RMA-number, Heraeus contact person of the ordering business unit, clear indication of the supplier / sender.
- RMA number on the outside of the packaging / box
- Return and delivery information
- Packing list
- Certificate of origin
- Certificates of analysis mandatory with the following values: LOI / LOR max. 0.05 % (see no. 2 "Specification of the Precious Metals" for sponge / powder)

4. Container / Packaging

The following information must be indicated on the containers / on the label:

- Gross weight
- Tare
- Net weight
- Analysis number (certificate)
- Material description
- Manufacturer / producer / refiner (brand)
- All containers must be sealed. The seal must be intact upon delivery.

5. Other Requirements

- One delivery or separate packaging per order
- Delivery documents including packing list must be sent to the recipient (Heraeus) before the delivery of the goods
